PZ3 Live follows its Exhibit Rules & Regulations from the International Association of Exhibition & Events (IAEE). All exhibitors must agree and sign the Exhibitor Rules & Regulations in order to exhibit. PAYMENT TERMS:

A 50% non-refundable Exhibit Space fee of the total is due at the time of booking to hold the space in the Exhibitor's name until the full payment is received. If paying by company check, ACH, or Wire Transfer, payment must be received within 15 days net upon receipt of the invoice. If the 50% non-refundable deposit is not received on the due date, booth space may be released. Full payment is due on Friday, January 24, 2025. Any new reservations received after Thursday, January 23, 2025, require full payment.

Note: The space reservation is not secured until the 50% deposit or full payment is remitted, and the signed Exhibit Space Application and Rules & Regulations are received and accepted by PetZONE360.

CANCELLATION POLICY:

A 50% refund (if already paid in full) may be eligible if notice is received in writing by Thursday, January 23, 2025. Send cancellation notice to msacasas@petzone360.com, or support@petzone360.com.

SPONSORSHIP PAYMENT TERMS:

- Due upon receipt
- If paying by company check, ACH, or Wire Transfer payment must be received within 15 days net upon receipt of the invoice.

SPONSORSHIP CANCELLATION POLICIES:

Once sponsorship has been published and promoted, there shall be no refund for any sponsorship items that have been secured and agreed upon. However, the Sponsor may cancel the Sponsorship and/or Advertising Agreement in writing (if no promotion has been made and no costs have been incurred by PetZONE360 or its vendors) and the Sponsor agrees to the following refund schedule:

- < 120 days before the first of the event (50% refund)
